#### SHORT BIO

I am a senior lecturer in the Department of Sociology and Anthropology and the Program in Cultural Studies at the Hebrew University of Jerusalem (PhD, 2014). In my doctoral research, I focused on gender performance among blind women, and on the cultural construction of blindness and sight in the Israeli public sphere. Between 2014 and 2020, I studied the field of Disability Culture in Israel and the US, conducting an ethnography with integrated dance companies bringing together dancers with and without disabilities. My current project examines the sensory practices and cross-sensory translation techniques of deaf, blind, and deaf-blind performers in integrated theater. My fields of research include disability studies, anthropology of the senses, gender studies, research of visual culture, and performance studies.
